

PROCEEDINGS OF THE MOTT CITY COUNCIL
December 12, 2016

The Council met for their monthly scheduled meeting on Monday, December 12th, 2016. Present were Mayor Mosbrucker, Council members Messmer, Steiner, Johnson, Quamme, Riedlinger, Wangsvick, and City Superintendent Mosbrucker. Also present were Sheriff Warner, Holly Ottmar, and Erin Oberlander. All motions are carried, unless otherwise stated.

Wangsvick moved and Riedlinger seconded the approval of the November Minutes.

Johnson moved and Messmer seconded accepting the police report as presented by Sheriff Warner. Investigations in November included a disturbance at the nursing home, a wandering person, a missing juvenile, 24/7 violation and a gas drive off. The Sheriff shared that there is one deputy finishing the Academy and another has been hired and will start the first of January.

Superintendent Mosbrucker reported that the City has been very busy moving snow. The new Bobcat has a problem with the hydraulic system where the filter housing broke off. We are waiting for bobcat to come and repair. They have also been helping to clear out the guard buildings. The Council asked that the public is reminded not to shovel snow into the street.

Last month the City was asked if a band can play in a bar if there are band members under 21? The answer is yes provided they are supervised by someone over 21. No spectators may be under 21 however.

West River Medical has a Scrubs Camp scheduled for 3/29 with 68 Mott and Lemmon kids signed up.

Steiner moved and Johnson seconded giving out the same Christmas bonuses as last year to Pam Steinke, Kerry Mosbrucker, Robbie Keller, Roger Senn and Frank Schmidt.

Steiner moved and Riedlinger seconded signing the Southwest Water Authority Contract as presented.

Wangsvick moved and Steiner seconded approving the following 2017 Liquor License applications: Pheasant Lounge, Scorpions, Colombian Club, Cenex, Mott Country Club and Hettinger County Fair Association. Wangsvick moved and Johnson seconded denying Bottoms Up Bar & Grill a 2017 Liquor License due to delinquent property taxes. Once property taxes are paid the Council will review the license application again.

Holly Ottmar and Erin Oberlander were at the meeting because the building where Just 4 the Health of It is operating has been sold. They were hoping to use a portion of the Armory for their classes. Johnson moved and Riedlinger seconded allowing them to use the back room of the armory, rent free for a six month trial period.
